Welcome to FisCalendar

FisCalendar is a Microsoft Excel application for configuring and printing calendars for any fiscal year, with automatic display of statutory holidays and day-of-year. It is designed primarily for people with accounting responsibilities.

FisCalendar requires Microsoft Excel 2003 or later, and a compatible Microsoft Windows operating system.

Installing FisCalendar

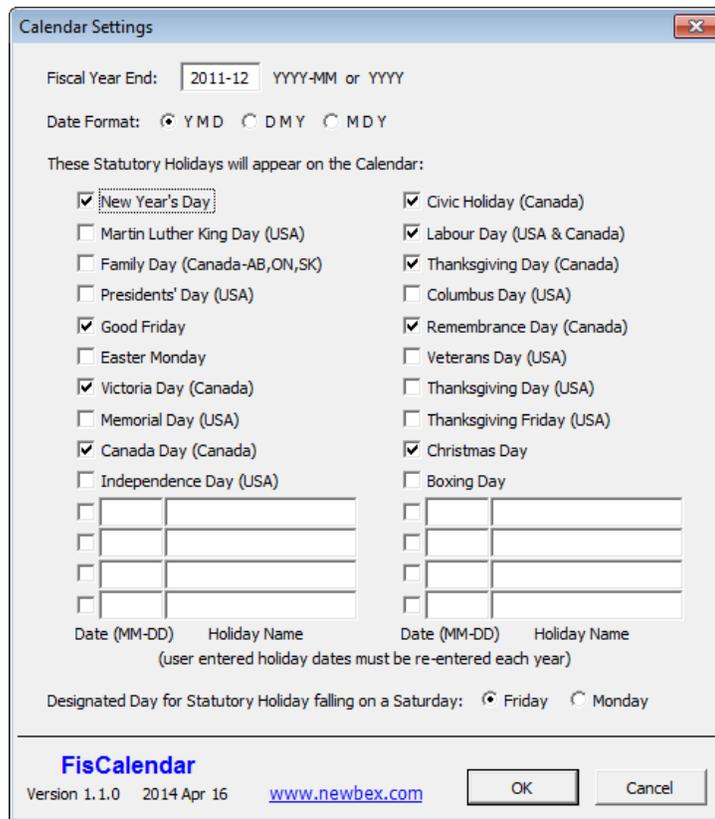
To install FisCalendar, simply copy its file to a handy place on your computer or server. No external files are ever created, so uninstalling is just as convenient if you choose to do so.

Using FisCalendar

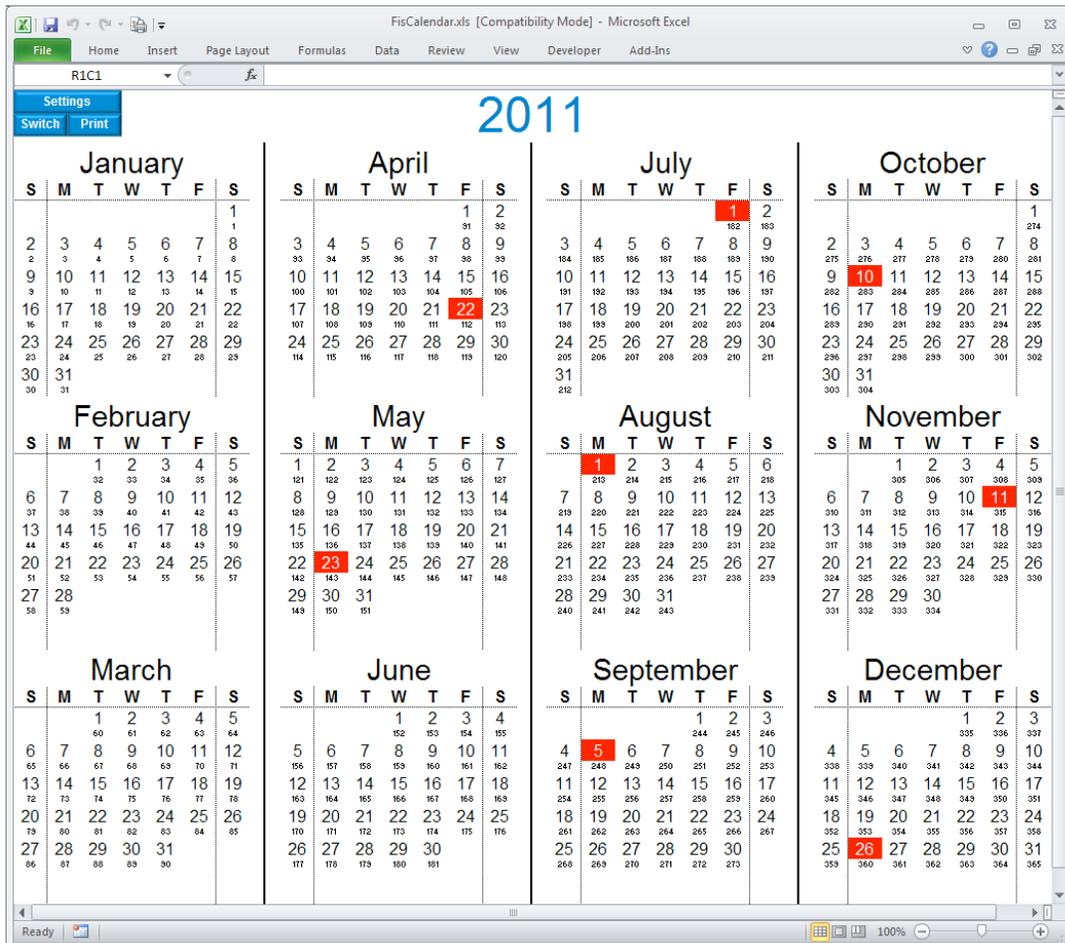
1. Double-click the FisCalendar icon to open it, then click the Settings button.
2. Configure the calendar as desired, then click OK.
3. Choose horizontal or vertical layout using the Switch button, then select Print.

Calendar Settings

- **Fiscal Year End** - The year and month of the next fiscal year end, normally the last month in a quarter.
- **Date Format** - Your preferred format for dates in FisCalendar.
- **Statutory Holidays** - These appear on the calendar as white text on a red background. In addition to the most common statutory holidays in Canada and the USA, up to eight user-defined holidays may be set. User-defined holiday dates should be updated each year.
- **Designated Day** - Determines if the designated weekday for a statutory holiday falling on Saturday is the Friday before or the Monday after. Holidays falling on Sunday are always moved to the Monday after.
