

## **GOLDBUG SOFTWARE LICENSE AGREEMENT**

This is a legal agreement between you, the end user, and the Goldbug Software. Be sure to read and understand all of the rights and restrictions described in the following agreement before using the Software.

By using the software (regardless of whether you have registered the software or not), you are agreeing to be bound by the terms of this agreement. If you do not agree to the terms of this agreement, delete all copies of the software and all accompanying files from any storage devices upon which you have placed it.

### **Description of Terms.**

The Software operates in two modes - registered and unregistered. The Software in its unregistered form is intended to serve as a demonstration of the capabilities of the Software in its registered form. The Software in its registered form is intended for use only by an individual that has purchased or been given a license and received a license key from the Goldbug Software. A valid license key will remove limitations from the unregistered Software and convert it to a registered version. A Temporary license key will also extend the period of demonstration or remove limitations for a certain period. The Software that you enter the Temporary license key for should be treated as registered Software during the period that the Temporary license key is valid.

### **1. Grant of License.**

The Goldbug Software grants to you (an individual) the right to install and use the Software in its unregistered form on any computer. If you purchase or are given a license and a license key for the Software, you may use the Software in its registered form on any computer on which you are the primary user, or on which you are the only person able to use the Software in its registered form. Once registered, the license to the Software belongs to the named individual. The license and the license key may not be sold or given to any other individual or organization.

### **2. Limitation of Use.**

You must maintain all copyright notices on all copies of the Software. You may not rent, lease, resell, or redistribute the registered Software to any other party. You may not alter, reverse engineer, decompile, disassemble, or modify the Software. You may not modify the Software or create derivative works based upon the Software.

### **3. Ownership.**

The forgoing license gives you limited rights to use the Software. Although you own the media on which the Software is recorded, you do not become the owner of, and the Author retains title to, the Software, and all copies thereof. All rights not specifically granted in this agreement, including International copyrights, are reserved by the Goldbug Software.

### **4. Copyright.**

All title and copyrights in and to the Software (including but not limited to all icons, images, files, and extensions incorporated into the Software), the accompanying printed materials, and any copies of the Software, are owned by the Goldbug Software. All title and intellectual property rights in and to the content which may be accessed through use of the Software is the property of the respective content owner and may be protected by applicable copyright or other intellectual property laws and treaties. This Software License Agreement grants you no rights to use such content.

### **5. Termination.**

This license is effective until terminated. You may terminate this license at any time by destroying the Software, related documentation and all copies thereof. This license will terminate immediately without notice if you fail to comply with any provision of this license. Upon termination you must destroy the Software, related documentation and all copies thereof. This license may be terminated by offering you a superseding Software License Agreement for the

Software or any replacement or modified version of or upgrade to the Software.
